

**18.** No suit, prosecution or other legal proceedings shall lie against the Collage, Council or any person for anything which is in good faith done or be intended to be done under this Order.

**19.** The Council may make rules for carrying out the purposes of this Order.

**20.** The Pakistan College of Physicians and Surgeons Ordinance, 1962 (XX of 1962), is hereby repealed.

- (x) Diploma in Gynaecology and Obstetrics (D.G.O.).
- (xi) Diploma in Ophthalmic Medicine and Surgery (D.O.M.S.).
