

Provided that where the compulsory retirement follows a period of suspension ordered under clause (2) of Article 11 of the Bangladesh Rifles Order, 1972 (P.O. No. 148 of 1972), such compensation pension or gratuity or provident fund benefits shall be admissible only for the period of service rendered excluding the period of suspension.

(2) A member who is compulsorily or prematurely retired from service shall not be entitled to any leave preparatory to retirement.]
